The report is divided into four sections: one for securities listed on the New York Stock Exchange, one for securities listed on The Nasdaq Stock Market, one for securities listed on the American Stock Exchange or regional exchanges, and one for exchange-listed options. For each section, this report identifies the venues most often selected by Gordon, Haskett Capital Corporation, sets forth the percentage of various types of orders routed to the venues, and discusses the material aspects of Gordon Haskett Capital Corporation's relationship with the venues.
